1. The premises shall at all times be kept in conformity with sanitary laws and regulations, clean and in good state of repair; no structural alterations are to be carried out without prior approval from the Social Care Standards Authority.
2. There shall be provided all the necessary facilities, equipment and personnel required to provide adequate care of the residents.
3. Fire fighting appliances and facilities shall be such as may be determined from time to time by the Competent Authority.
4. The licensee shall ensure, as far as is reasonable practicable that old people kept at the home enjoy the freedom and security they would anticipate in their own home, in an environment comfortable and suitable for old people.
5. The licensee shall afford reasonable facilities to elderly residents so that they can maintain the fullest possible social, mental and physical activity.
6. Proper facilities shall be available at all times for nursing in the home residents who are ill but who do not require hospital treatment.

Medical practitioner or practitioners shall be attached to each home so as to provide the medical care and general health requirements which the resident elderly may require.

The licensee shall ensure proper care for the adequate safekeeping of medicinal used by the resident elderly.

7. The licensee shall take all reasonable steps to minimise risk of accidents to the residents, and shall within 24 hours

report to the Social Care Standards Authority, occurring in Home.

8. The licensee shall provide suitable furniture, facilities and/or fittings for non-ambulatory elderly and for those who cannot cope by themselves for their personal needs without such aid or aids.
9. The licensee shall provide reasonable social and recreational facilities for residents. The licensee shall moreover ensure that the residents have facilities to receive visitors privately.
10. Adequate arrangements or facilities are to be available at all times so that the elderly can receive prompt attention whenever they need help especially in an emergency.
11. The licensee shall keep registers showing the names and former private address of residents' elderly, their age, and particulars of nearest relative.
12. The Social Care Standards Authority is to be informed of the name, age, address and qualifications of all personnel employed by the licensee at time of receipt of licence, and of any new personnel employed thereafter.
13. No new resident shall be admitted to the home unless he has been examined by a medical practitioner and certified free from infectious disease and each new resident shall moreover have a Chest X-Ray taken within 1 week of admission to the home.
14. The premises shall be open for inspection by an officer authorised by the Social Care Standards Authority for ensuring due observance of the conditions of this licence.
